

I understand The Barkley is not responsible for any pre-existing medical conditions or any other infectious conditions, medical problems or injuries that may become affected as a result of the grooming process. I acknowledge and am aware that the employees of The Barkley are not veterinarians, do not have backgrounds in animal medicine and should not be expected to diagnose or detect illnesses. I recognize that the Salon & Spa services, along with the unpredictable movements of animals, can present aesthetic consequences along with certain risks of injury including, but not limited to: cuts, nicks, burns, scratches, irritated or discolored skin, kwiking of nails, etc. If my Pet becomes sick or injured and requires professional attention, I designate The Barkley as full and lawful agent and understand that The Barkley, in its sole discretion may engage the services of a veterinarian and the full expense shall be paid by me.
- 3. I agree to pay for the services requested at pick-up and understand that if I do not pick up my Pet by closing time, my Pet will be boarded overnight at the published nightly rate. I authorize The Barkley to make full, unlimited, worldwide use of my Pet's name, likeness and biographical material in connection with The Barkley's business and understand I will receive no compensation for granting such rights.
- 4. I agree to hold The Barkley, its owners, operators, employees, officers, directors and contractors harmless from any damage, loss, or claim arising from any condition of my Pet, either known or unknown to The Barkley. I further agree to be solely responsible for any and all acts or behavior of my Pet while it is in the care of The Barkley, including payment of costs for injury to staff members, other animals or damage to facilities caused by my Pet.
